The Ministry of Economy and Infrastructure has received financing from the World Bank toward the cost of the Local Roads Improvement Project and intends to apply part of the proceeds toward payments under the contract for the upgrading works on the Local Road **Section 1: Corridor 13, Section 2: Corridor 8.3 and Section 3: Corridor 11.**

2. The Ministry of Economy and Infrastructure represented by the Î.S. “Administrația de Stat a Drumurilor” now invites sealed bids from eligible bidders for Works for **“Improvement Works on Section 1: Corridor 13, Section 2: Corridor 8.3 and Section 3: Corridor 11”** inclusive of all the necessary road improvement activities including earthworks, road pavement rehabilitation/widening, repair works to structures, intersections, structures, drainage, incidental and safety facilities, road marking, signing and sidewalks, rearrangement of engineering services, etc.

3. Bidding will be conducted through the International Competitive Bidding procedures as specified in the World Bank’s *Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers, ed. January 2011, revised in July 2014* (“Procurement Guidelines”), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank’s policy on conflict of interest.

4. Interested eligible bidders may obtain further information from Î.S. “Administrația de Stat a Drumurilor” at the address given below.

5. 6. Bids must be delivered to the address below on or before **10.00 AM, April, 12th, 2018**. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who choose to attend at the address below at **10.15 AM, April 12th, 2018**.

7. All bids must be accompanied by a Bid Security of 200,000.00 USD.
