**Assignment Title:** Construction Supervision Services for Local Roads Improvement Project

The Government of the Republic of Moldova has received financing from the World Bank toward the cost of the Local Roads Improvement Project in Moldova, and intends to apply part of the proceeds for consulting services.

The project will be implemented under the general supervision and responsibility of the Ministry of Economy and Infrastructure (MEI), who will execute the project through the State Road Administration (SRA) as the direct executing agency.

The consulting services (“the Services”) include Contract Administration and Construction supervision of the civil works, which consist of rehabilitation and upgrading of about 300 km of regional and local road – priority corridors, within the available budget of US Dollars 75 million. The current status of implementation for the selected prioritized corridors, in accordance with the current Procurement Plan, is summarized in Table 1.

#### Assignment Start and Duration:

It is envisaged that the current assignment, funded from the World Bank financing, will commence in November 2018, for a duration of about 29 months.

Supervision services may be extended beyond 29 months, subject to the actual needs and provided that the loan closing date is extended.

#### Requirements for EOIs:

The SRA now invites eligible consulting firms (“Consultants”) to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services.

The EOI should provide the following information:

#### 1. Company Profile:

- Company profile, core business, staffing levels and technical capacity, annual turnover;
- Details of applicant’s standard quality policies, procedures and practices;
- Name, qualifications and relevant experience of firm's director or manager who will assume overall responsibility for project team’s coordination, management and output;
- Specific details of applicant’s procedures to ensure quality of its performance over the life of this assignment including management coordination and role of each firm.

## 2. Experience:

Provide up to 10 projects references in similar road construction supervision assignments, undertaken in the previous five (5) years, which the applicant considers best illustrate its experience relevant to the assignment, to include the following details:

- Project title, and narrative description of the project;
- Contractual role of the firm;
- Detailed description of the actual services provided by the firm;
- Name of firm's senior staff (Project Director, Team Leader) involved and functions performed;
- Number of staff and number of person-months of professional staff provided by the firm;
- The presence of any lead or affiliate companies and their respective roles;
- Detailed description of the actual services provided by affiliate companies;
- Number of staff and number of person-months of professional staff provided by affiliate companies;
- Location, and start and completion dates;
- Works Contract value;
- Supervision Contract Value;
- Name of the Client and funding source;
- Details of the works supervised including the following aspects:
  - Supervision of the works in accordance with FIDIC Conditions of Contract for Construction (MDB Harmonized edition, 2010) / WB General Conditions of Contract for Large and Small Works;
  - Review / approval of Construction Drawings;
  - Preparation of Variations, Analysis of Claims / Compensation Events in accordance with Conditions of Contract;
  - Contract administration (correspondence, reports, minutes of meetings, document control / contract records, reporting to Employer and Funding agencies);
  - Environmental / Social monitoring and reporting;
  - Bridge Rehabilitation / Construction;
  - Drainage structures (culverts / ditches);
  - Earthworks construction;
  - Cold in place asphalt recycling;
  - Cement stabilised pavement construction;
  - Asphalt mix design and construction (binder, SMA);
  - Roadside furniture (signs, safety fencing and road marking);
  - Relocation of Utilities (gas / water / electrical / communications).

The information on the company's profile shall be submitted in accordance with Table A and the information on company's experience in accordance with Table B of the attached Annex 1.

The Expression of interest is to be in English language and should not exceed 50 pages.

For shortlisting purposes, the combined experience of a joint venture will be evaluated although the qualifications of the lead firm will be given a greater weight.

**Procurement procedure:**

A shortlist of qualified firms will be prepared on the response to this invitation, after which shortlisted firms will be invited to submit their proposals. A Consultant will be selected in accordance with the QCBS (Quality-and Cost-Based Selection) method set out in the Consultant Guidelines.
