Louis Berger SAS confirmed its participation on May 21, 2008, and BCEOM Societe Francaise D'Ingenierie on May 22, 2008.

Due to the fact that Kocks Consult GmbH, Poyry Infra Gmbh and SARI International did not accumulate the minimum qualifying score of 80 points, their financial proposals will not be opened and will be returned unopened, after the contract signing with the winning consultant.
