Opening:

<u>Mr. Gheorghe Curmei</u> welcomed all the participants and introduced the SRA' representatives attending the meeting. Further he pointed out to the participants that the event was held in accordance with para 7.4, Section I - Instructions to Tenders, Tender Documents aimed at clarifying issues and answering questions on any matters that may be raised at this stage.

<u>Mrs. Caraman Tatiana</u> drawn the participants' attention to the clauses from the Tender Documents of outmost importance such as the period of validity of Tenders and Tender Security, the amount of Tender Security required for each contract, the written confirmation of authorization to sign the Tenderer and requirements to be met for post-qualification stage.

<u>Mr. Lionel Etherington</u> explained in more detail the purpose of the post-qualification stage which precedes awarding the contract(s).

<u>Mr. Serghei Polisciuc</u> pointed out some aspects on the scope of works for two subject works contracts, funding source of the project and the governing national law on quality in construction.

Questions and Answers:

<u>Mr. Gheorghe Curmei</u> requested companies' representatives to address their questions in writing before the deadline for requests for clarification. Mr. Gheorghe Curmei specified that all questions will be formally answered through the Minutes of the Pre-Tender Meeting and Clarifications that will be sent to all invited prospective Tenderers.

Closing:

At the end, Mr. Gheorghe Curmei thanked representatives of firms and joint ventures for their attendance and wished them success in the tendering process.

Requests for clarification on the Tender Documents:

After the pre-Tender meeting and subsequent site visit a considerable number of requests for clarifications from the prospective Tenderers have been received. Responses to requests for clarification will be distributed shortly, will become part of the Tender Documents and will be



binding on participants.

Taking into account the number of requests for clarifications received, an Addendum for extension of tender submission deadline will be issued together with these Minutes in order to give the prospective Tenderers reasonable time for tenders preparation and to allow the Employer to answer to all the requests.

In order to address all the queries raised by the tenderers, upon answering to requests for clarifications, another Amendment to the tender documents will be issued.
