## **Section 1: Letter of Invitation**

No party other than the Client shall derive any rights from the financing agreement or have any claims to the proceeds of the credit.

The Client now invites proposals to provide the following consulting services (hereinafter called "Services"): Project Implementation Support.

It is expected that the assignment will commence in January 2025 with duration of 3 years, with further possibility for extension, subject to availability of funds and project needs. More details on the Services are provided in the Terms of Reference.
