The Ministry of Infrastructure and Regional Development, represented by the State Road Administration, hereinafter referred to as “the Employer/Client/Promoter”, intends using part of the proceeds of a credit from the European Investment Bank (the Bank) towards the cost of Rehabilitation Works on R34 Hîncești - Leova - Cahul - Giurgiulești road, km 82+000 – 125+000.

The Employer/Client/Promoter now invites sealed tenders from participants for the following Contract to be funded from part of the proceeds of the credit: **Rehabilitation Works on R34 Hîncești - Leova - Cahul - Giurgiulești road, km 82+000 – 125+000.**

The project “Rehabilitation Works on R34 Hîncești - Leova - Cahul - Giurgiulești road, km 82+000 – 125+000” consists of the rehabilitation and full depth reconstruction works of existing road.

The project starts at roundabout km 83+025 of R34 road – Cantemir town, and continues up to km 124+769, entrance in the Cahul town, beginning to railway crossing.

The works to be carried out includes the section with new road construction, rehabilitation of existing pavement, widenings, including arrangement of side roads to the agricultural fields and arrangement of minor intersections, entrance to the properties. Construction of retaining wall and underground drainage system, slope protection, bridges constructions. Arrangement of drainage facilities as construction of the culverts, consolidated lined side drains and outside interception ditches.

Estimated Contract signing is expected in March 2025. Time for Works’ Completion is 30 months, and 24 months of the Defects Notification Period.

The main works will consist of:

- Earthworks over 300,000 cub.m;
- Asphalt Concrete Pavement Milling to any depth over 55,000 cub.m;
- Cold recycling of the asphalt concrete pavement over 375,000 sq.m;
- Asphalt layers over 80,000 tonnes;
- Construction of six bridges;
- Construction of pipe and box culverts at different dimensions over 1,000 l.m.;
- Construction of consolidated channels over 9,500 l.m.;
- Install of 10,000 l.m. of guardrail;
- Installation of over 850 signs;
- Application of over 15,500 sq.m of thermoplastic road marking;
- Arrangement of power lines over 140 poles, including underground cables of over 4,000 l.m.;
- Arrangement of communication cables of over 2,000 l.m.;
- Arrangement of underground gas pipeline over 600 l.m.

The scope of works is estimated and is for guidance only. The final scope will be determined based on the measured quantities of implemented works.

Firms originating from all countries of the world are eligible to tender for this works contract. Pursuant to its Sanctions Policy, the Bank shall not provide finance, directly or indirectly, to or for the benefit of an individual or entity that is subject to financial sanctions imposed by the EU, either autonomously or pursuant to the financial sanctions decided by the United Nations Security Council on the basis of article 41 of the UN Charter.
